#### **Program:**

- Briefing and common supper on the first evening of the course
  - Common supper on the second evening with animated 'fuel-talk'.
  - 7 hours of free driving (personal coaching as an option)

  - 7,5 hours of section training (in long sections)
  - Small groups (max. 16 participants), subdivided into sub-groups with 8 participants
  - Each sub-group is accompanied by a coach / instructor
  - Final examination laps with detailed analysis followed by an award ceremony and participant distinction

## IMPLEMENTATION RULES OF THE EVENT

### Requirements for the driver and the car:

- The car must be in perfect conditions. It conforms to the Road Traffic Regulations (StVO).
- A valid liability insurance has to be produced at the check-in desk.
- If the driver is not the owner of the car, the participant has to present a declaration of consent of the owner to the event-organizer.
- Each person participates at its own risk and peril.
- Seat belts and crash helmets have to be worn at all the time during the course. Windows, sun-roofs must be shut.
- The organizer assumes no liability against person, material and pecuniary loss either for material loss of the racetrack.
- Liability for damages is not assumed.
- Any individual costs such as overnight stays, fuel, technical services, tires, etc. are not included in the price.
- Exhaust pipe noise must fit with the conditions of the Nürburgring 1927 GmbH. Usually: 98 + 2 DBA

## REGULATIONS

### 1. Type of event

Course for safe driving on a racetrack. The event provides road safety and discipline. The achievement of top speed is not the matter of the course as competition is not permitted. The event conforms to the Road Traffic Regulations (StVO).

### 2. Intention of the event

Advancement of safety consciousness, fairness and of exact and precise reactions in the road traffic. Practice of coordinated interaction between driver/car/street and traffic.

### 3. Participation conditions

The following persons are allowed to participate at the Scuderia S7 course:

- Participant is in possession of a valid driving license, allowing to drive the vehicle intending to use.
- Participant is the owner of the car. If he is not, he has to present a declaration of consent of the owner to the event-organizer.
- Participant's car is in perfect conditions, is covered by liability insurance and conforms to the Road Traffic Regulations (StVO).

### 4. Insurance

Participants are not insured against any risks connected to the event. If necessary the comprehensive cover is to clarify with the own insurance company.

### 5. Safety arrangements

Seat belts and crash helmets have to be worn at all the time during the course. Windows/sun-roofs must be shut. Directions of the staff/stewards/instructors must be followed all times. Anyone in breach of the rules will be disqualified/excluded from the event. In such a case no money will be refunded.

### 6. Exclusion of liability

Driver and co-driver are required to sign the declaration "exclusion of liability" before the event.

### 7. Labelling of the cars

Before the beginning of the event, each participant will receive individual start-numbers which have to be fixed on the car. After the event the numbers have to be removed instantly.

### 8. Modification of eligibility requirements

In case of 'force majeure' or for safety reasons or also modifications caused by authorities or track owners, the organizer is authorized to change the eligibility requirements. In the worst case the event can be cancelled.

### 9. Participant fee and notification

The participants fee has to be paid at the moment of the notification, or by check or by bank transfer. The subscription is treated after reception of the total amount.

The following services are included: rental of the circuit, catering, charges for instructors and coaches, personnel costs, costs for ambulance and security staff (if required).

The number of participants is limited. Please notify your participation exclusively with the official entry form. An incomplete entry form cannot be treated. The entry forms are treated with the 'first In, first served' principle. While signing the entry form, the participant accords to the general conditions of the event's organizer.

### 10. Cancellation

For any participant's cancellation of the course before **30<sup>th</sup> of August 2020**, the cancellation fee is as follows: 1st Driver: 1.500,- EUR, 2nd Driver / Accompanying person: 150,- EUR. No money will be refunded for any cancellation done after this date. As a precaution we recommend the participants to conclude a travel cancellation insurance (not included in the course fee.) In case of contestation, the german edition of the regulations ("Ausschreibungsbestimmungen") are effective.
